**7:15 p.m.** **Fernhill Natural Treatment System Update**  
The Fernhill Wetlands Improvement and Reuse Project has evolved into a natural treatment systems showcase that will provide many ancillary benefits—habitat improvements, aesthetics, education, passive recreation—while expanding capacity at a much lower cost than conventional facilities. In 2012, ~2 acres of treatment wetlands, the Water Garden, and foot bridges were constructed. Last year, a new parking area was added and design continued for what will become 90 acres of treatment wetlands. This year, a new entry corridor opens and construction will begin on the South Wetlands. This presentation will describe how staff, consultants and the community are putting in tremendous effort to ensure success at Fernhill for water quality, birds and people.
